

## **1. Authorised use of personal information**

When supplying CYBERBIKES with your personal information and accepting our terms and conditions, you allow to:

Use your data to create a designated network account to power your CYBERTRACKERS' Device (s) and services.

Create your account on a pre-paid, annual billed basis.

## **2. Authorised use of the Services**

The Services enable the owner of a CYBERTRACKERS device and Cyberbikes to follow the Device's location.

You allow Cyberbikes to store the tracked location and other data related to your assets to improve our software and services further.

## **3. Compliance with laws and regulations**

You agree that the vehicle with a Cybertracker installed does not comply with any criminal activity and that the GPS device will not be used to stalk, harass, harm, threaten or invade any person's privacy other than to identify the location of your assets.

Cyberbikes cannot be liable for how users will use their devices in a civil society. Therefore, any illicit use of the Services is not authorised by Cyberbikes and is undertaken at your own risk, with chances of having your services terminated at the discretion of Cyberbikes and without previous notice.

## **4. Cybertrack Liability**

Any use of the Services is at your own risk. CYBERBIKES makes no representations or warranties about the Services' accuracy, reliability, completeness, timeliness, or results obtained from using the Services.

We reserve the right to modify or discontinue the Services (or any part or content thereof) without notice at any time due to unforeseen circumstances that may arise with the use of GPS tracking technology, policies and services of third-party network providers.

## **5. Modification of Prices And Services**

Prices for CYBERBIKES products are subject to change without notice.

We shall not be liable to you or any third party for any modification, price change, suspension, or discontinuance of the Service. Annually you will receive an e-mail with information about the new prices.

## **6. Accuracy of billing and account information**

We reserve the right to refuse any order you place with us. We may limit or cancel quantities purchased per person, household, or order at our sole discretion. These restrictions may include orders placed by or under the same customer account, credit card, and demands using the same billing or shipping address. Suppose we make a change to or cancel an order. In that case, we may attempt to notify you by contacting the e-mail or billing address/phone number provided when the customer made the order. In addition, we reserve the right to limit or prohibit orders that, in our sole judgment, appear to be placed by dealers, resellers or distributors. You agree to provide current, complete and accurate purchase and account information for all purchases made at our store. You agree to promptly update your account and other information, including your e-mail address, credit card numbers, and expiration dates, so that we can complete your transactions and contact you as needed.

## **7. Prohibited uses**

In addition to other prohibitions as outlined in terms of Service, you are prohibited from using the CYBERTRACKERS' site or its content:

CYBERBIKES is not responsible for refunding the purchase of a CYBERTRAKER after the cancellation of services.

The User should return the Device to the dealer to avoid any problems due to illegal use possibilities.

These Terms of Use shall continue for as long as you use the Services provided; however, your use will terminate automatically without notice from CYBERBIKES if you fail to comply with any of these terms and conditions. In addition, CYBERBIKES reserves the right to discontinue offering any data or services provided by a third party if such supplier ceases to supply such data or services to CYBERBIKES or CYBERBIKES's contract with such supplier terminates for any reason.
